**1. For Five Year B.A., LL.B. (Hons.):**

- Up to 4,000 CLAT Rank (All India General) Category only need to apply.
- Up to 25,000 CLAT Rank (All India) in the AP SC Category only need to apply.
- Up to 11,000 CLAT Rank (All India) in the AP-General Category only need to apply.
- Up to 5,000 CLAT Rank (All India) in the ALL INDIA EWS Category only need to apply.

**2. For One Year LL.M. Program:**

The Candidates securing

- Up to 4,000 CLAT Rank (All India) Category only need to apply.
- AP SC candidate having CLAT 2023 Rank in SC Category can apply.
- Up to 5,000 CLAT Rank (All India) in the AI-EWS Category only need to apply

3. Last date to make an application is on or before **JUNE 25, 2023 BY 11.59 PM**
