ACADEMICS

THREE-YEAR LL.B.

DSNLU introduces Three-Year LL.B. from the Academic Year 2024-25. The Three-Year LL.B. is offered to candidates across India. Three Year LL.B. students are required to complete 144 credits. The admission to Three Year LL.B. Course of the University is based on all India Entrance Examination following the reservation policy as per the Government of Andhra Pradesh.

The academic programs are designed to provide intensive training and exposure to various aspects in the study of law. Students are exposed to innovative opportunities to legal learning through classroom teaching, tutorials, projects, group discussions, seminar presentations on chosen topics apart from a rigorous examination process. The academic activities are intertwined with the participation in moot court competitions, parliamentary debates, seminars, conferences, workshops and quiz programs organized by various Institutions, Universities and Law Schools. The students of the University also undertake summer and winter internship with Judges, Law firms, Advocates, Quasi-judicial, State Institutions, and NGOs to gain hands-on experience and expertise in the field of law.

The University has the credit of being the one of the National Law University, to enter into 'Memorandum of Understanding' for student exchange programs with other National Law Universities at Bangalore, Kolkata, Patna, Patiala and Delhi.

ACADEMIC ACTIVITY

In consonance with the aims of the University to advance learning and knowledge in law and legal processes, DSNLU periodically organises various guest lectures, moots, seminars, conferences, workshops, etc. appropriate to the time and need.

EXAMINATION EVALUATION

The Department for Promotion of Industries and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India, launched a Scheme for Pedagogy & Research in Intellectual Property Rights (IPRs) for Holistic Education & Academia (SPRIHA) in the year 2016 under which IPR Chairs have been set up in select universities and academic institutes in accordance National IPR Policy, 2016. 

INFRASTRUCTURE FACILITIES

DSNLU state-of-the-art, technologically advanced and eco-friendly campus is situated in 45.5 acres abutting the hill. DSNLU campus has fully air-conditioned Academic Block, Wi-Fi enabled with LAN facility. The University is a part of National Knowledge Network whereas the Government of India has provided 1GBPS connectivity to the University. Boys and Girls Hostels consists of 250 rooms each with two student's accommodation. DSNLU has canteen building accommodating 350 students at a time. DSNLU has 11 KV Sub-station with two 320 KVA backup generators, 1.5 KLD capacity Sewage Treatment Plant, Union Bank of India ATM. Roof Top Solar Power Plant with 350 KWP capacity was also commissioned.

The students are facilitated with a world-class library which provides access to online resources like Westlaw India, Hein Online, Manupatra, SCC online, Lexis Advance India, JusMundi, Taxmann, JSTOR, LiveLaw, Bar & Bench, Economic and Political Weekly, Lexis Knowledge, EBC Reader, Cambridge University Press E-Books, Oxford Legal Research Library, Oxford ICSID Review etc., for intensive research. The online resources are available through Knimbus Portal. Further, DSNLU adopts Turnitin, an anti-plagiarism web tool. All the classrooms are equipped with LCD projectors, internet and public address system. DSNLU Moot Court Hall is a splendour in its own way. The University has a seminar and conference hall that are made available for conducting meetings, organizing guest lectures and events. In furtherance of expanding its horizons and to stay efficient and competitive, the University is further constructing 15 classrooms.

THE REDRESSAL COMMITTEES

DSNLU has established the following Redressal Committees as per the UGC Regulations.

- 1. Internal Complaints Committee(Sexual Harassment at workplace)

- 3. The SC & ST Grievance Redressal Committee

ADMISSIONS

i) **Eligibility:** Candidates have to clear the Entrance Test conducted by DSNLU (DET) complying with all the eligibility criteria.

The Candidates for 3 year LL.B. should have passed any Graduate Degree (10+2+3 pattern) of a recognized University or any other examination recognized as equivalent by the Universities concerned with 45% of aggregate marks for general category, 42% for BC category and 40% for SC/ST. If any candidate secured less than 45%, 42% and 40% respectively in graduation as stated above, he / she should have secured same percentage or more on the aggregate in any additional graduation or Post Graduation.

Note: The percentage of 44.5% and above in aggregate in graduation (10+2+3 Pattern) in case of candidates belonging to general categories, 41.5% or above in aggregate in graduation (10+2+3 Pattern) in case of candidates belonging to BC category and 39.5% and above in aggregate in graduation (10+2+3 Pattern) in case of candidates belonging to SC/ST category will be considered as 45%, 42% and 40% of aggregate marks respectively for admission into LL.B 3 year course.

ii) Intake:

Three Year LL.B. - 120 seats + 18 Extra Seats* (Total–138 seats) (See point No 8 & 9 below).

RULES OF RESERVATION

- 1. The seats in the University shall be filled as follows; Out of the total sanctioned seats
 - (i) fifty percent of the seats shall be filled as per the rules of AP State;
 - (ii) forty percent of the seats shall be allotted on All India basis;
 - (iii)remaining ten percent of the seats allotted to Foreign Citizens / Non-Resident Indians / Non-Resident Indians Sponsored.
- 2. If seats reserved for candidates from the State of Andhra Pradesh are not filled for want of eligible

candidates, such vacant seats shall be filled from the candidates of other states as per the ranking secured in the DET.

- 3. Seats will be distributed among the open and reserved candidates as per the table given below:
- 4. The seats reserved for STs shall be made available to SCs and vice-versa, if qualified candidates are not available in that category.
- 5. If qualified candidates belonging to SCs and STs are not available, the left-over seats reserved for them shall be treated as unreserved seats and shall be filled by the candidates of general pool.
- 6. If qualified candidates belonging to BCs of a particular group are not available, the left-over seats can be adjusted for the candidates of next group.
- 7. If qualified candidates belonging to BCs are not available to fill up the 29% seats reserved for them, the left-over seats shall be treated as unreserved and shall be filled up with candidates of general pool from all India ranking.
- 8. Twelve extra seats are under the category of EWS, GO Ms. No.39 dated 30.07.2019 of Government of Andhra Pradesh.
- 9. Six extra seats are under the category of Wards of Kashmiri Migrants and Kashmiri Pandits / Kashmiri Hindu Families (Non-Migrants) as per UGC guidelines.
