**IMPORTANT INSTRUCTIONS**

Applications are invited from the eligible candidates for admission into 5 Year Integrated B.A. LL.B. (Hons.) and 1 Year LL.M. programs of DSNLU for the Academic Year 2025-26 for seats allotted under Foreign Citizens / NRI / NRI Sponsored category.

**UG - 12 (Twelve) seats**

**PG - 06 (Six) seats**

It is informed that for admission into UG/PG courses, DSNLU is governed by CLAT 2025 Notification with regard to eligibility criteria.

As per the CLAT 2025 Notification the following is the eligibility criteria for filling of the seats under the Foreign Citizens / Non-Resident Indians Category.

- i. The Minimum 45% of marks in 10+2 / Intermediate or its equivalent for admission to UG Programme.
- ii. An LL.B. Degree or an equivalent examination with a minimum of 55% of marks or its equivalent grade for admission to PG Programme.
- iii. The Foreign Citizens need not appear for CLAT.
- iv. The Non-Resident Indians (NRIs) seeking admission in either of the UG/PG programmes have to appear in CLAT 2025.

In view of the above provisions and eligibility criteria, the applicants seeking admission into UG and PG Programmes of DSNLU under Foreign Citizens / Non-Resident Indians / Non-Resident Indians Sponsored category have to fulfill the following eligibility criteria as noted:

**1. Foreign Citizens:**

The Candidates under Foreign Citizens category to be admitted directly on the basis of their percentage of marks in 10+2 / Intermediate or its equivalent. In case of any grading system is followed the equivalent percentage will be taken into consideration. The Foreign Citizens need not appear for CLAT.

**2. Non-Resident Indians (NRI):**

The Candidates under Non-Resident Indians (NRIs) category to be admitted on the basis of CLAT-2025 NRI Category Merit List.

**3. Non-Resident Indians (NRI) Sponsored:**

The Candidates under Non-Resident Indians (NRI) Sponsored category to be considered and admitted on the basis of All India CLAT Rank against the vacant seats, if any, after filling the Foreign Citizens / NRIs category. The candidate has to submit the NRI Sponsorship letter.

Interested Candidates seeking admission into UG/PG programmes under Foreign Citizens /NRI / NRI Sponsored Category has to submit the application in the format available at DSNLU website [www.dsnlu.ac.in](http://www.dsnlu.ac.in) with necessary supporting documents along with application processing fee of Rs. 5,000/- (**non-refundable**) by online payment to The Registrar, Damodaram Sanjivayya National Law University, Visakhapatnam. The duly filled in scanned application along with the details of online payment and necessary enclosures are to be submitted to [admissions@dsnlu.ac.in](mailto:admissions@dsnlu.ac.in) on or before 30-06-2025 The University will not consider incomplete and late applications.

The merit list of Foreign Citizens / NRI / NRI Sponsored category will be displayed in DSNLU website on 03-07-2025.

Selected candidates should appear online and attend the counseling on 05-07-2025 with all the documents for verification and pay the following fees, on the date of counselling as applicable, to The Registrar, Damodaram Sanjivayya National Law University, Visakhapatnam to complete the admission process.
