Candidates are hereby informed that the deadline for submission of applications for admission into the 3-Year LL.B. programme for the Academic Year 2025–26, as per Admission Notification dated 02.05.2025, has been extended. Applications may now be submitted via email until **June 27, 2025**.

Please note that the **DSNLU Entrance Test (DET)** will be conducted **only at the DSNLU campus in Visakhapatnam** on **June 29, 2025 (Sunday)**, from **11:00 AM to 1:00 PM**.

Note:

- All candidates are required to appear for the DET **only at the DSNLU campus, Visakhapatnam**.
- The **DET admit card number** (no hard copy will be issued) will be communicated to candidates via **email and the University website on Saturday, June 28, 2025**.
- Candidates must carry a valid **photo ID proof** (original) for verification. **No candidate will be allowed to appear for the test without a valid ID proof.**
- Candidates must report to the test centre **at least one hour before** the commencement of the examination.
- Candidates must **make their own travel and accommodation arrangements**. Limited on-campus accommodation is available on first cum first basis from 28/06/2025 on payment of Rs. 600/- per day, subject to **availability of rooms**.
- **No request for postponement of the DET or change of venue will be entertained** under any circumstances.
- Candidates must bring **all original relevant documents** along with **one set of self-attested photocopies** for verification.
- After successful document verification, candidates must be prepared to pay the admission fee via **NEFT (online transfer)** to the Registrar, DSNLU using the following account details.
