The following are the norms for candidates to apply for vacant seats

1. For Five Year B.A., LL.B. (Hons.):

The Candidates securing

- Up to 5,000 CLAT Rank (All India General) Category only need to apply.
- Up to 7,000 CLAT Rank (All India) in the OBC Category only need to apply.
- Up to 15,000 CLAT Rank (All India) in the SC Category only need to apply.
- Up to 25,000 CLAT Rank (All India) in the ST Category only need to apply.
- Up to 20,000 CLAT Rank (All India) in the BC-B-AP Category only need to apply.
- Up to 15,000 CLAT Rank (All India) in the AP-General Category only need to apply.
- Up to 6,000 CLAT Rank (All India) in the AI-EWS Category only need to apply.

2. Last date to make an application is on or before July 03, 2025 BY 11.59 PM

3. The University will notify the merit list on July 04, 2025 by 03:00 pm The shortlisted candidates notified in the merit list shall mail the Specified Documents to admissions@dsnlu.ac.in

4. The candidates who are not shortlisted will be in waiting list.

5. The candidates will be invited for counselling on July 07, 2025 10.30 am onwards.

6. Applications received beyond the above mentioned ranks shall not be considered for counselling.
