Notification for Vacant Seats of 5 year B.A. LL.B. (Hons) and One Year LL.M.

DSNLU has decided to close the admissions by 18.08.2025 for the academic year 2025-2026, as classes have already commenced. In view of this, candidates interested in joining DSNLU against the vacant seats shall register and appear for spot admission physically on 18.08.2025 at 10.00 Hrs. The vacant seats will be allotted as per the CLAT 2025 rank and the following categories seats are available:

1. For Five Year B.A., LL.B. (Hons.):

- Up to 5,000 CLAT Rank (All India General) Category candidates who applied for Vacant Seat Notification dated 30.06.2025 are eligible to participate in spot admission. *(if no candidates attended for spot admission the seat will be allotted to the spot registration candidates.)*
- Up to 6,000 CLAT Rank (All India) in the AI EWS category candidates who applied for Vacant Seat Notification dated 30.06.2025 are eligible to participate in spot admission *(if no candidates attended for spot admission the seat will be allotted to the spot registration candidates.)*
- For All India SC category candidates are required to register physically at DSNLU, Visakhapatnam from 10:00 am to 11:00 am based on the registration and as per CLAT 2025 Rankings seats will be allotted.

2. For One Year LL.M.:

- All India General Category candidates who applied for PG Vacant Seat Notification dated 15.07.2025 are given preference in spot admissions, *(if no candidates attended for spot admission the seat will be allotted to the spot registration candidates.)*
- AP STATE General & ST candidates are required to register physically at DSNLU, Visakhapatnam from 10:00 am to 11:00 am based on the registration and CLAT 2025 Rankings seats will be allotted.
- FC/ NRI/ NRI Sponsor Candidates having NRI/ NRI Sponsor CLAT Rank only are eligible to apply.
